LSP SOCIAL MONTORING REPORT AS OF JUNE 2020 ACTION PLANS

Update on Project's Construction Activities



- Total area: approx. **464 ha** (398 ha for the main site and 66 ha for the port area)
- Main products: The designed production capacity for the first phase is 3.45 million tonnes of petrochemical products (i.e. Ethylene, Propylene, HDPE, LLDPE, Polypropylene, and Butadiene) per year.

The **key milestone** of the Project is presented as follows:



The Project's overall progress was **66.1% by 31 Dec 2020**. **Main EPC contractors**



Supplemental Resettlement Action Plan

- As of September 2018, total acquired land area: 677.63 hectares affecting 602 affected households and organization.
- By April 2020, almost complete compensation payment except for two (02) HHs from the Main Site;
- As of April 2020, Vung Tau People's Committee (VTPC) had allocated 226 land lots for 178 AHHs of the Project in phase 1 of Long Son Resettlement Site (LSRS). 29 other households are waiting for land lots in Long Son Resettlement Site Phase 2;
- Resettlement site construction is completed
- In 2021, LSP will continue to actively follow up with the local authorities to support the pending resettlement cases.

Livelihood Restoration Action Plan

- As of June 2020, opened 04 Vocational Training courses on forklifting, tailoring, welding, cooking and excavator, restaurant servicer and construction worker. Total 120 PAPs joined the training courses. A pilot training on Thai foods cooking was organized for 2020;
- Organized 02 training workshops in Micro, Small and Medium Business for around 80 affected Small-Medium enterprises;
- Organized 02 handicraft training classes for 15 women in Hamlet 1 and Ben Diep hamlet; and
- Supported a group of 05 affected women and 01 affected household to sell food and beverage in the rest shelters on site.

Community Development Action Plan

- Local Recruitment Support: LSP's Social team engaged with EPC contractors and sub-contractors to disclose and promote the Project's local employment and procurement policy.
- Community Health and Safety Promotion: LSP organized several training workshops on the topic, such as Traffic Safety Awareness Raising, Alcohol and Drug Abuse Prevention, Health Education and Infectious Diseases Prevention program, Mobile clinic program with 200 – 300 participants on average in each event.
- Scholarship Program: Since its start in 2016, the company has granted 240 scholarships for primary and secondary school students who belong to vulnerable households in Long Son commune. In addition, two (2) scholarships were granted to students in Long Son under the SCG's Sharing the Dream scholarship program.
- Provided financial support to improve local infrastructure.
- Other CSR activities such as organizing English speaking club at Bach Dang secondary school, attending cultural events in Long Son.

Stakeholder Engagement Pla

Since November 2018, the One Manager One Community (OMOC) program was utilized as a channel for public consultation and information disclosure, as well as building relationship with local communities. The OMOCs are organized once a month and focusing on disclosing Project information and obtaining feedbacks from community regarding its construction activities and other social programs.

Besides, the Project also conduct on-going stakeholder activities in the community.
