Processing Guidelines

The actual extrusion condition depends on type of using machine, size and film thickness of product required. Generally, melt temperature should be $180^{\circ}\text{C}-200^{\circ}\text{C}$ with blow up ratio (BUR) = 3-5 times and frost line height (FLH) = 8-10 times of die diameter.
